This information should match your tax receipt from STO4KIDZ, unless you carry credit s forward from a previous year.





Steps to make your 2019 tuition tax credit contribution on TurboTax:

Determine your contribution amount.



If unsure about you tax liability, refer to your previous year tax form, or complete your tax on TurboTax before contributing, this way you see your exact tax liability, then redo the process to reflect your contribution.

NOTE: Your tax liability is the total annual tax amount you pay the state, not what you owe. (Line 47 of your state tax form shows your tax liability)

NOTE: A school tuition organization cannot award, restrict, or reserve scholarships solely on the basis of a donor's recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent. A.R.S. 43-1603 (C). Any designation of your own dependent as a potential recipient is prohibited.
