

Arizona Dollar-for-Dollar Tax Credits

~You can contribute to each one of them ~

⇒ **Private School Corporate Tuition Tax Credit:** Arizona allows 'C' and 'S' Corporations, as well as insurance companies with Arizona tax or premium tax liability, to redirect up to 100% of their taxes to [STO4KIDZ](#), a certified School Tuition Organization, and receive a dollar-for-dollar tax credit. To participate, the company does not have to be based in Arizona, provided it pays Arizona tax liability. (Read [Fact-Sheet](#)) ([Click here for tax forms](#))

*Both Private School Corporate and Individual tax credits provide scholarships to K-12 students with verified financial need.

⇒ **Qualifying Charitable Organizations (QCO)** (This credit is claimed on [form 321](#))

- **2024:** \$938 married filing joint / \$470 single, married filing separate or head of household.

⇒ **The Arizona Military Family Relief Fund Credit**

- \$800 - Filing Jointly/ Married
- \$400 - Filing Single

Visit the [Arizona Military Family Relief Fund](#) website to contribute. You will have to mail a check with the printed form. This contribution must be made by December 31, and the fund can only accept a total of \$1 million in donations, so once that limit is reached, any more donations received are returned.

Please consult your tax advisor for your eligibility.

NOTE: Arizona law now requires all school tuition organizations to print the following notice on all printed materials and websites. A school tuition organization cannot award, restrict, or reserve scholarships solely on the basis of a donor's recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent. A.R.S. 43-1603 (C). Any designation of your own dependent as a potential recipient is prohibited
